Immigration benefit requestors may request that USCIS expedite the adjudication of their applications or petitions. USCIS considers all expedite requests on a case-by-case basis and generally requires documentation to support such requests. The decision to grant or deny an expedite request is within the sole discretion of USCIS.[1]

Expedite Criteria or Circumstances

On or after June 9, 2010, USCIS may expedite a benefit request if it falls under one or more of the following criteria or circumstance:

- Severe financial loss to a company or person, provided that the need for urgent action is not the result of the petitioner's or applicant's failure: (1) to timely file the benefit request; or (2) to timely respond to any requests for additional evidence;<sup>[2]</sup>
- Emergencies and urgent humanitarian reasons;<sup>[5]</sup>
- Nonprofit organization (as designated by the Internal Revenue Service (IRS)) whose request is in furtherance of the cultural and social interests of the United States;
- U.S. government interests (including urgent cases for federal agencies such as the U.S. Department of Defense, U.S. Department of Labor, DHS or other public safety or national security interests); [6] or
- Clear USCIS error.

Severe Financial Loss as a Basis for Expedited Treatment

A company can demonstrate that it would suffer a severe financial loss if it is at risk of failing, losing a critical contract, or required to lay off other employees. For example, a medical office may suffer severe financial loss
