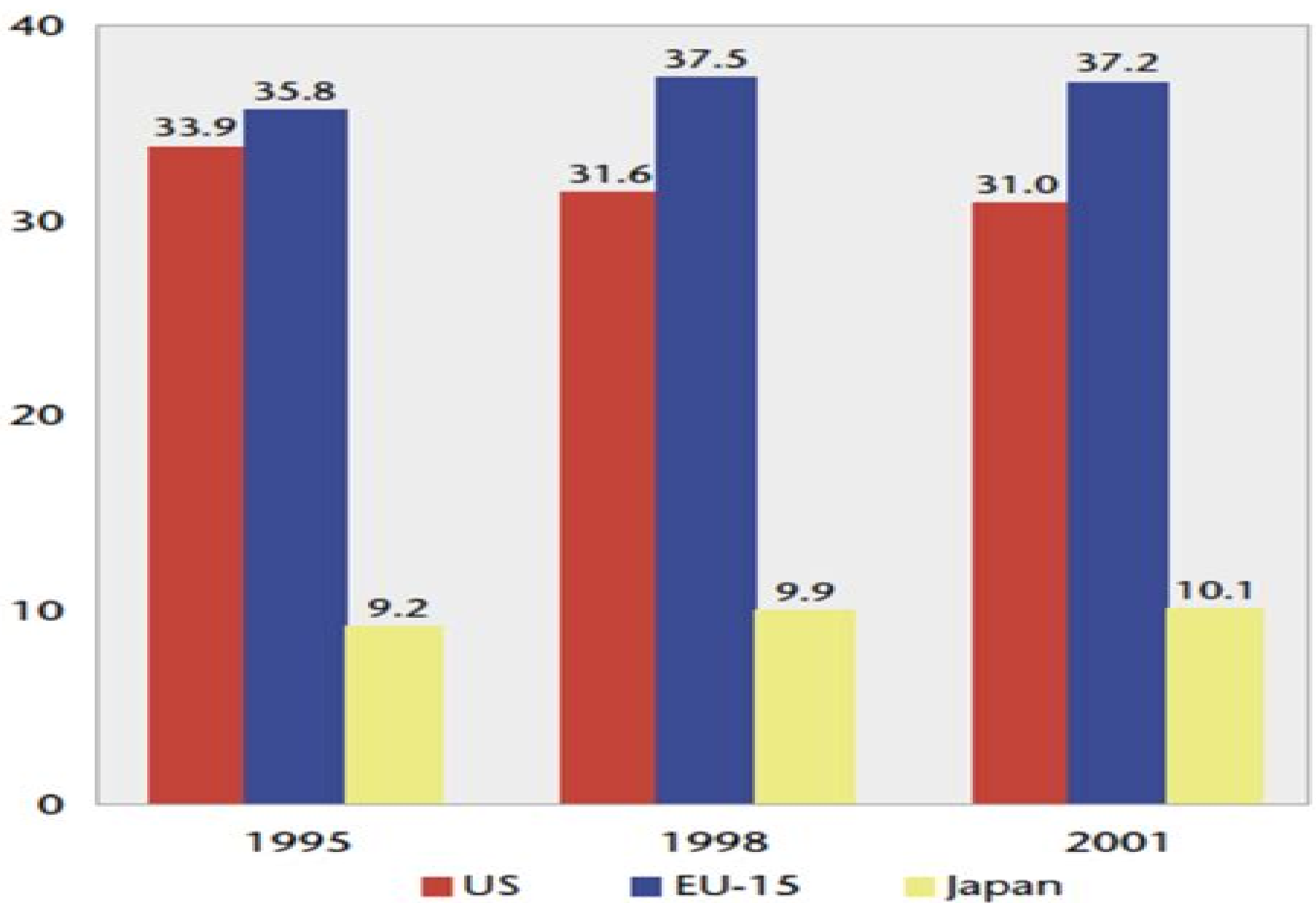


Figure 5.2.1.b Publication shares (%) by EU-15, US, Japan (1995, 1998, 2001)
