Technological factors

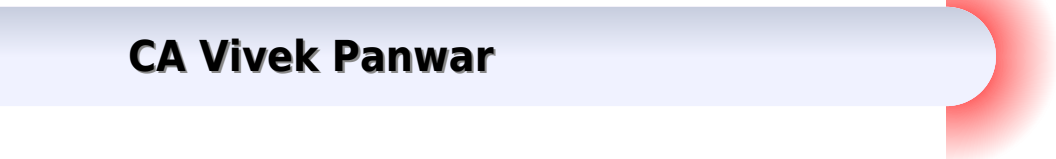
Answer: capture the application of knowledge to create new processes and products
