THE PARTIES AGREE AS FOLLOWS:

1. Services to Be Performed

Contractor shall provide Carrier transportation of all kinds (FAK) by motor vehicle as a contract Carrier and desires to transport goods for Carrier; and to facilitate such transportation and for the convenience in handling such transaction. Contractor represents and warrants that Contractor has title to or is authorized to contract the Equipment and services to Carrier.

This Agreement shall not be construed as an agreement by Carrier to furnish any specific amount of goods, materials, or loads for transportation by Contractor in any particular time or place. Carrier makes no guarantee of minimum payment for use of the Contractor Equipment. Likewise, Contractor shall have the right, at its discretion, to decline to transport any shipment tendered to it by Carrier, or to refuse to perform specific requests by Carrier to provide transportation.
